



## BREEDING CONTRACT

The stallion fee is **\$1650** which includes a **\$350** non-refundable booking fee which is payable upon execution of the contract. The remainder of the stallion fee **\$1300** is due prior to the first semen shipment. If the stallion fee is not paid in full, semen will not be sent.

A photo copy, of the registration papers on your mare must accompany this contract. The owner recorded on the registration papers will be the owner recorded on the stallion breeding report.

This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, or a mare absorbs/aborts a predetermined pregnancy there are return privileges, only if Crown K. is notified within 7 days and receives a statement confirming this. A "Live Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be sent to Crown K.

If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, the Stallion Manager agrees to breed the same mare again during the following year's breeding season. There is a rebreed fee of \$350 for 2 extra doses plus any applicable shipping expenses. A substitute mare, accepted by Crown K, may be used ONLY if the original mare is deceased or deemed unfit for breeding by a licensed, attending veterinarian.

A Breeders Certificate will be issued for the (1) foal conceived as a result of the breeding. The Breeders Certificate will be issued only after all expenses have been paid in full and insemination date reported via email to Crown K prior to 30<sup>th</sup> May 202\_\_\_\_\_. Failure to notify of AI date ,any AQHA penalty costs for late breeders certificate will then be at mare owners cost.

Neither Crown K Quarter Horses. nor any of its officers or employees shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle.

Crown K Quarter Horses sole liability under this contract is in the event the stallion should die or become unfit for breeding purposes and no frozen semen is available, this contract shall terminate and any money paid on the stallion fee, except the non-refundable booking fee, shall be refunded to the Mare Owner.

When signed by both parties, this document will become a legally enforceable contract, binding both parties. The parties acknowledge that this agreement is made and shall be considered to be entirely performed within the State of NSW and shall be construed and enforced under the laws of the State of NSW.

### Frozen Semen

A request for frozen semen will be forwarded along with this contract. All shipping expenses incurred are the Mare Owner's responsibility and must be paid directly to Semen Storage Facility at Tamworth Equine Vets. AI costs incurred for the mare are mare owner's responsibility. The semen will not be shipped until service fee and freight charges are paid in full.

This contract and semen is for 1 breeding, 1 foal, any unused semen can be used the same year for another approved mare, or following year for 1 breeding, provided \$1650 service fee is paid in full and upon execution of another Crown K contract. Any leftover semen, mare owner must notify Crown K .
